

NH-ISAC Navigator Program Agreement

GENERAL TERMS AND CONDITIONS

By signing this agreement, you ("Navigator), agree to become a Navigator to, and to participate in, the National Health Information Sharing and Analysis Center ("NH-ISAC"). Navigator affiliation in NH-ISAC is contingent upon approval by NH-ISAC, Inc., and potential subsequent reviews and approval determinations by NH-ISAC and payment of applicable fees. By executing this Agreement, Navigator agrees to the terms and conditions of this Agreement which are incorporated into this Agreement by this reference and which are available at www.nhisac.com under the "About NH-ISAC" tab. NH-ISAC will provide written or electronic notice of any changes to the Rules.

1. Background.

NH-ISAC is a group of entities in the Health care and Public Health sector for the purposes of providing members with timely, accurate, and actionable warnings of physical, operational, and cyber threats or attacks on the National Health infrastructure or individual companies, and for collecting and providing information on potential vulnerabilities in the National Health infrastructure.

2. Affiliation.

(a) The NH-ISAC Navigator application process attempts to verify the accuracy and legitimacy of all applicant companies and company representatives requesting access to the NH-ISAC. Security of the NH-ISAC is a paramount concern and information and vetting resources ranging from industry to government will be used. In order to become a Navigator of NH-ISAC, an entity must be approved for membership by the NH-ISAC.

(b) Navigator agrees to be contacted by the NH-ISAC for the purpose of verifying (1) the existence of the company, (2) accuracy of address and physical location, (3) the applying individual is a valid employee of the applicant company with authority to bind the Navigator, (4) the applicant company is in good standing with the NH-ISAC Board of Directors.

(c) Navigator benefits are itemized in Addendum 1.

ADDENDUM 1

NAVIGATOR PARTICIPATION AGREEMENT

The Navigator is participating as a Participant and agrees to the NH-ISAC Navigator Agreement GENERAL TERMS AND CONDITIONS. The effective date of participation will begin upon full
